ASSIGNMENT

This Assignment is effective nunc pro tunc as of January 30, 1996 and is by and between Lane Meats Co., Inc., an Oregon corporation, previously having a mailing address of Box 23838, Eugene, Oregon 97402, and Frank J. DeBenedetti, Jr. (hereinafter collectively called Assignor), and Western Boxed Meats Distributors, Inc., an Oregon corporation, having an address of 2401 NE Argyle, Portland, Oregon 97211 (Assignee);

WHEREAS, Assignor is the Registrant, by way of an Assignment of January 1, 1993, of U.S. Registration No. 1,460,248 for the mark CATTLE LAND for processed meats, namely, beef, pork, veal and poultry; fish, which issued on October 6, 1987 (hereinafter the Registration);

WHEREAS, on January 30, 1996, Assignor previously assigned the CATTLE LAND mark, Registration and good will of the business associated with the mark to Assignee;

WHEREAS, some ambiguity may exist in the ownership of the CATTLE LAND mark at the time of the Registration;


NOW, THEREFORE, the parties agree as follows:

1. Lane Meats Co., Inc. and Frank J. DeBenedetti, Jr. hereby assign to Western Boxed Meats Distributors, Inc., effective nunc pro tunc as of January 30, 1996, all worldwide rights, title and interest in and to the mark CATTLE LAND, together with the good will of the business associated with the mark CATTLE LAND, together with all right, title and interest in and to U.S. Registration No. 1,460,248.

2. Lane Meats Co., Inc. and Frank J. DeBenedetti, Jr. hereby confirm that they have not at any time, including times on or subsequent to January 30, 1996, assigned or otherwise transferred any rights in the mark CATTLE LAND or in the Registration to any party other than Western Boxed Meats Distributors, Inc.


