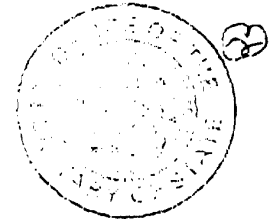

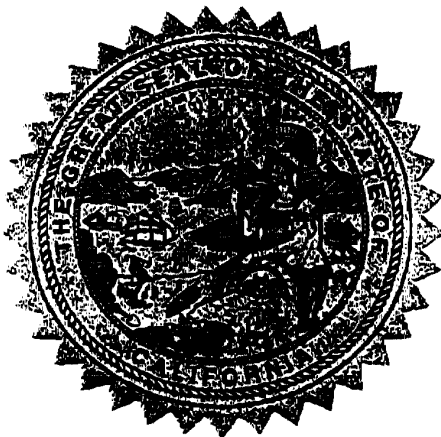

1. They are the duly elected and acting President and Secretary, respectively, of said Corporation.

2. The Articles of Incorporation of said Corporation shall be amended by revising Article I. in full to read as follows:

"Article I. Name. The name of the corporation is The Dialog Corporation."

3. The foregoing amendment has been approved by the Board of Directors of said Corporation.

4. The Amendment herein set forth has been duly approved by the required vote of the shareholders in accordance with Section 902 of the Corporations Code. The Corporation has only one class of shares outstanding and the number of shares outstanding is 7,375 shares of Common Stock. The number of shares voting in favor of the Amendment equaled or exceeded the vote required. The percentage vote required for the approval of the Amendment herein set forth was more than 50%.



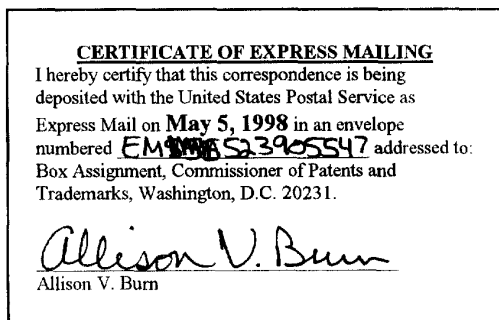
