BOULDER TRADEMARK ASSIGNMENT

THIS ASSIGNMENT OF REGISTERED TRADEMARKS is made this 24th day of August, 1997, by and between Boulder Publishing, Inc., a Colorado corporation ("KRI Subsidiary"), and Monterey County Herald Company, a California corporation ("Scripps Subsidiary").

WHEREAS, pursuant to an Asset Exchange Agreement, dated as of July 25, 1997 (as amended, the "Exchange Agreement"), by and among Knight-Ridder Inc., a Florida corporation and the sole stockholder of KRI Subsidiary ("KRI"), KRI Subsidiary, The E.W. Scripps Company, an Ohio corporation and the sole stockholder of Scripps Subsidiary ("Scripps"), and Scripps Subsidiary, KRI Subsidiary has agreed to assign to Scripps Subsidiary and Scripps Subsidiary has agreed to accept from KRI Subsidiary, for the consideration and upon the terms and conditions set forth in the Exchange Agreement the Boulder Trademarks. WHEREAS, Scripps Subsidiary desires to acquire the entire right, title and interest in and to the Boulder Trademarks and the goodwill appurtenant thereto;

NOW THEREFORE, for good and valuable consideration paid by Scripps Subsidiary to KRI Subsidiary, the receipt and sufficiency of which are hereby acknowledged, KRI Subsidiary does hereby assign and transfer unto Scripps Subsidiary all of its right, title and interest in and to the Boulder Trademarks, together with the good will appurtenant thereto.


