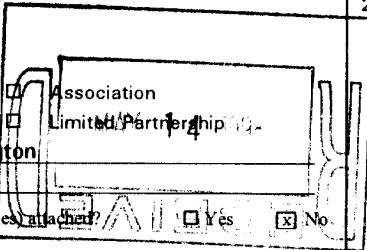

1. The present name of the corporation is Barbieri Hospitality, Inc.

2. The amendment to the Articles of Incorporation is to replace the existing Article I to change the name of the corporation to Goodale and Barbieri Companies as follows:

3. The date of adoption of this amendment was July 15, 1985.




6. The amendment does not provide for exchange, reclassification, cancellation of stock or change in the amount of stated capital.
