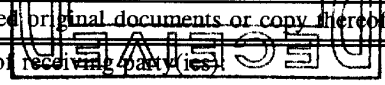

PARTIAL TRADEMARK ASSIGNMENT

WHEREAS, STEARNS AIRPORT EQUIPMENT COMPANY I, L.L.C., a Texas limited liability company, having an address of 1717 Walnut Hill, Suite 104, Irving, Texas 75038 (hereafter "Assignor"), successor by merger to Stearns Airport Equipment Co., Inc. of Texas, acquired the mark herein described from TRN Business Trust and is the owner of all right, title and interest in and to the Trademark Registration set forth on Exhibit A attached hereto, and the mark therefor (hereafter the "Mark");

WHEREAS, THYSSEN STEARNS INC., a Delaware corporation, having an address of Henschelplatz 1, D-34127, Kassel, Germany (hereafter "Assignee"), desires to acquire the right to use the Mark and the registration therefor in its passenger bridge boarding business (the "PBB Business") only;

WHEREAS, Assignor desires to retain the right to use the Mark and the registration therefor in its baggage handling system business and other businesses except the PBB Business; and

WHEREAS, Assignor and Assignee have entered into that Tradename/Trademark Co-Existence Agreement dated April 1, 1998 (the "Trademark Agreement") pursuant to which they agree as to their respective rights to the use of the Mark.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Assignor does hereby grant, assign and set over to Assignee, its successors, assigns and legal representatives, the partial right, title and interest in and to the

Mark for use only in connection with the PBB Business, together with the goodwill of the PBB Business symbolized by the Mark throughout the world;

Assignor also assigns unto Assignee all claims for damages by reason of infringement related to the PBB Business prior to the assignment date of the Mark through the world, with the right to sue for and collect the same for its own use and benefit, and for the use and benefit of its successors, assigns and other legal representatives.

Assignor and Assignee agree that the provisions of the Trademark Agreement will be controlling as to any conflict between its provisions and those set forth herein.

IN WITNESS WHEREOF, the parties and their duly authorized representatives have caused this Partial Trademark Assignment to be executed on the date and in the capacities shown below.

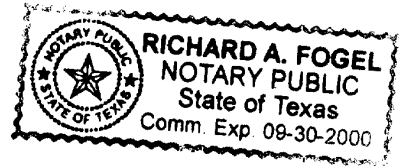

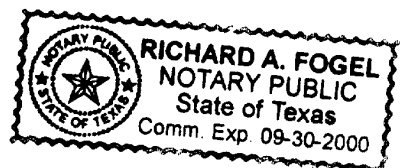


