Assignor hereby assigns, transfers and conveys to Assignee all right, title and interest in and to the Trademarks through-out the world, together with (i) the goodwill and the business symbolized by the Trademarks and (ii) all rights and privileges pertaining to the Trademarks, including, without limitation, all causes of action, claims and demands and other rights for, or arising from, any infringement, including past infringements, of the Trademarks.






