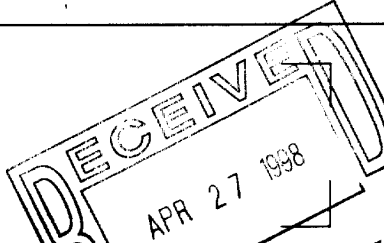





2. Buyer is responsible for notifying the appropriate party or parties with respect to this assignment.


