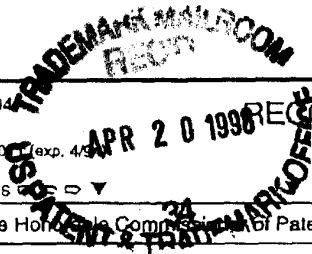

**TRADEMARK ASSIGNMENT**

WHEREAS, ComStream Holdings, Inc., a Delaware corporation ("Holdings"), ComStream Corporation, a Delaware corporation ("ComStream"), a successor in interest to ComStream Corporation, a California corporation, and ComStream Israel Limited, a Israeli corporation ("ComStream Israel", and together with Holdings and ComStream, "Assignors"), and Rockwell Semiconductor Systems, Inc., a Delaware corporation ("Rockwell"), are parties to that certain Asset Purchase Agreement dated as of April 7, 1997, as amended (the "Agreement") and to the Technology Transfer and License Agreement (the "TTLA"), pursuant to which, among other things, Assignors agreed to sell, transfer, assign, and convey to Rockwell all right, title and interest in and to the trademark owned by Assignors listed in Exhibit A attached hereto;

This Assignment is made pursuant to and is subject to all of the terms of the Agreement and the TTLA.
