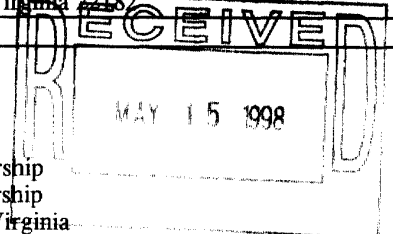

1. The name of the corporation is:


Post-Newsweek Business Information, Inc.


