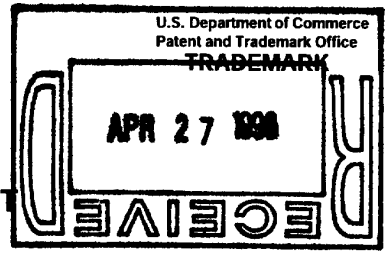

TRADEMARK ASSIGNMENT AND BILL OF SALE

KNOW ALL MEN BY THESE PRESENTS, that J & M DESIGNS, LTD., a California corporation ("Seller"), for good and valuable consideration, the receipt and adequacy of which is hereby acknowledged, has bargained and sold to, and by these presents does, grant, bargain, convey, assign, transfer, set over and deliver unto, ROWE FURNITURE CORPORATION, a Nevada corporation ("Rowe"), all of Seller's right, title and interest in and to the trademarks and the U. This Assignment and Bill of Sale is being delivered in accordance with, and is subject to the terms and conditions set forth in, the Purchase Agreement, the terms, scope and provisions of which shall control for purposes of this Trademark Assignment and Bill of Sale, it being understood that Wexford has assigned its right under the Purchase Agreement to purchase the Trademarks to Rowe, and that Rowe shall have such rights under the Purchase Agreement with respect to the Trademarks as Wexford would have if it had not assigned such rights to Rowe.

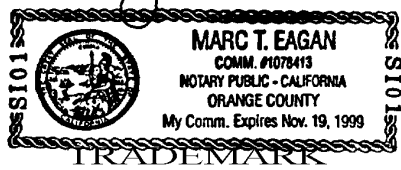
