RELEASE OF SECURITY INTEREST

THIS RELEASE OF SECURITY INTEREST, dated as of April 30, 1998 (the "Release"), is a release of the security interest in all Trademark Registrations and Applications covered by that certain INTELLECTUAL PROPERTY SECURITY AGREEMENT dated as of August 8, 1996 (the "Agreement"), among EZ BUY & EZ SELL RECYCLER CORPORATION, a Delaware corporation (the "Borrower" or a "Grantor") and each other person listed on the signature pages thereof (each such person individually a "Grantor" and collectively, together with the Borrower, the "Grantors"; and WELLS FARGO BANK, NATIONAL ASSOCIATION, a national banking association, as collateral agent (in such capacity, the "Collateral Agent").

The Agreement was recorded with the Assignment Division of the United States Patent and Trademark Office on August 15, 1996, on Trademark Reel 1492, Frame 0793 et seq.

Accordingly:

Section 1. Release from Security Agreement Interest in all Trademarks, Trademark Registrations and Applications.

(a) The Grantors have fulfilled all their obligations under the Agreement and the Collateral Agent hereby releases from the Agreement its security interest in the Trademarks, Trademark Registrations and Applications listed on Schedule I hereto.

SECTION 2. GOVERNING LAW. THIS RELEASE SHALL BE GOVERNED BY, AND CONSTRUED IN ACCORDANCE WITH, THE LAWS OF THE STATE OF NEW YORK, EXCEPT TO THE EXTENT THAT THE VALIDITY OR PERFECTION OF THE SECURITY INTERESTS GRANTED OR PURPORTED TO BE GRANTED HEREUNDER, OR REMEDIES PROVIDED HEREUNDER, IN RESPECT OF ANY PARTICULAR TRADEMARK COLLATERAL ARE GOVERNED BY THE LAWS OF THE UNITED STATES OR ANY OTHER JURISDICTION OTHER THAN THE STATE OF NEW YORK.
