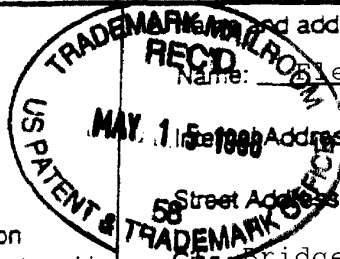

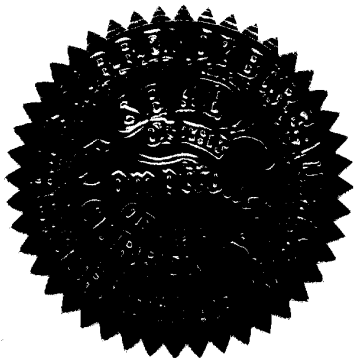

This is also the official authorization given to Fleet Bank, National Association to operate the branches of the target institution and to operate the former main office of the target bank as a branch as follows:

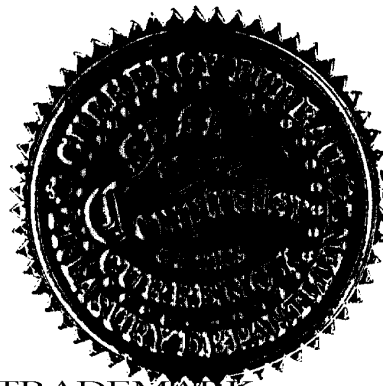
