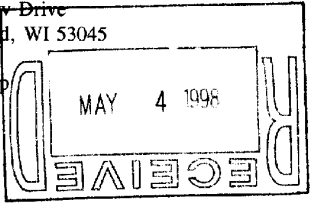

has assigned, sold, transferred, conveyed and bequeathed unto Assignee any and all of Assignor's right, title and interest in and to the Property.


