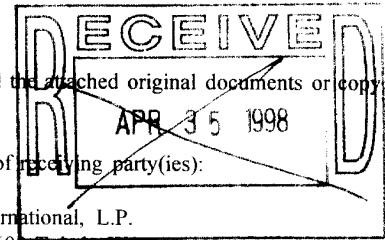

TRADEMARK ASSIGNMENT

WHEREAS, ASSIGNOR adopted, used, and to the best of its knowledge and belief, was the owner of the trademark GOTCHA, and all other rights appurtenant thereto, including, but not limited to, all common law rights, trade name rights, causes of action, and the right to recover for past infringement (hereinafter collectively referred to as "Trademark") worldwide;

WHEREAS, ASSIGNOR acquired goodwill associated with and symbolized by said Trademark and did not abandon the same;

WHEREAS, ASSIGNOR is the owner of Federal Trademark Registration No. 1,686,063 for the Trademark;

WHEREAS, ASSIGNEE has previously acquired all rights, title, and interest in and to the Trademark and the Registration; and

NOW, THEREFORE, for good and adequate consideration, the receipt and sufficiency of which is hereby acknowledged, ASSIGNOR hereby confirms that it has assigned and sold to ASSIGNEE all rights, title, and interest as ASSIGNOR may possess in and to the following:

- (1) the Trademark; and
- (2) the Registration;

together with the goodwill symbolized by said Trademark and Registration, concurrent with the transfer of certain tangible assets as indicia of said goodwill.
