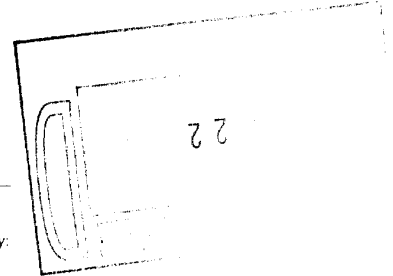

RELEASE

THIS RELEASE, granted on this 14th day of ^{May} ~~March~~ 1998, is delivered by THE BANK OF NOVA SCOTIA, in its capacity as the collateral agent (the "Collateral Agent") under the Security Agreement referred to below.

W I T N E S S E T H

WHEREAS, PLITT THEATRES, INC., a Delaware corporation, (the "Grantor") and the Collateral Agent have entered into a Security Agreement, dated as of June 23, 1994, pursuant to which the Grantor granted to the Collateral Agent a security interest in, among other things, all rights, title and interest in and to, among other things, the United States trademarks set forth on Schedule "A" hereto (the "Trademarks");


WHEREAS, the grant of the security interest was evidenced by, among other things, the Agreement (Trademark) between the Grantor and the Collateral Agent dated as of June 23, 1994 and filed with the United States Patent and Trademark Office (Reel 1179, Frame 105); and

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Collateral Agent hereby releases its security interest in the Trademarks and discharges, quit claims and relinquishes unto the Grantor (in each case, without recourse and without any representation or warranty) any and all rights, title and interest it has in and to the Trademarks, and more particularly hereby releases the security interest granted to the Collateral Agent under the Security Agreement and the security interest in the Trademarks.
