Gilson H. Rohrback and Duane L. Storkel, certify that:

1. They are the President and Secretary, respectively, of Rohrback Corporation, a California corporation.
2. The following amendments to the Articles of Incorporation of Rohrback Corporation have been approved by the Board of Directors of the corporation.

The Articles of Incorporation of this corporation are amended to read in full as follows:

I.

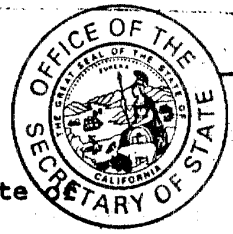
The name of the corporation is: Rohrback Cosasco Systems, Inc.

II.

The purpose of this corporation is to engage in any lawful act or activity for which a corporation may be organized under the General Corporation Law of California other than the banking business, the trust company business or the practice of a profession permitted to be incorporated by the California Corporations Code.

III.

This corporation is authorized to issue only one class of shares of stock and the total number of shares which this corporation is authorized to issue is Two thousand (2,000)."



3. The Amendment was approved by the required vote of Shareholders in accordance with §902 of the California Corporations Code and the Articles of Incorporation: the total number of outstanding shares entitled to vote or consent with respect to the Amendment was 400 shares representing 100% thereof and 400 shares voted or consented in writing to approve the Amendment.
