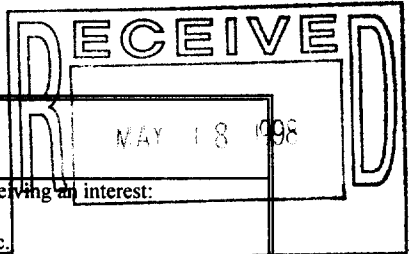

TRADEMARK RELEASE

THIS RELEASE granted on this 16th day of July 1997, by THE BANK OF NOVA SCOTIA ("Scotiabank") as agent (together with any successor(s) thereto in such capacity, the "Agent") for each of the Lender Parties, pursuant to a Credit Agreement dated December 19, 1994, as follows:

W I T N E S S E T H

WHEREAS, GENTEK BUILDING PRODUCTS, INC., a Delaware corporation, (the "Grantor"), and the Agent have entered into a United States Security Agreement, dated December 19, 1994, pursuant to which Gentek Building Products, Inc., a Delaware corporation, granted to the Agent a security interest in all rights, title and interest in and to the United States trademarks and trademark applications set forth on Schedule A hereto, (the "Trademarks"), said granting of said security interest having been evidenced by the Security Interest Agreement executed by Gentek Building Products, Inc., a Delaware corporation with offices at 29325 Chagrin Boulevard, Cleveland, Ohio 44122; and


WHEREAS, the Agent wishes to (i) terminate the Security Agreement against the Trademarks identified in Schedule A hereto attached, recorded with the United States Patent and Trademark Office (ii) release its security interest covering the Trademarks and (iii) restore all rights, title and interest in and to the Trademarks, to Gentek Building Products, Inc., a Delaware corporation and (iv) to dissolve any and all liens and encumbrances respecting the Trademarks.

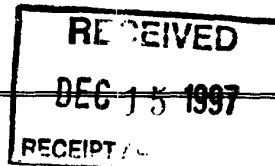


