"V.

The Corporation shall have authority, acting by and through its Board of Directors, to issue not more than Fifty Million (50,000,000) shares of Common Stock having a par value of \$0.05 per share."

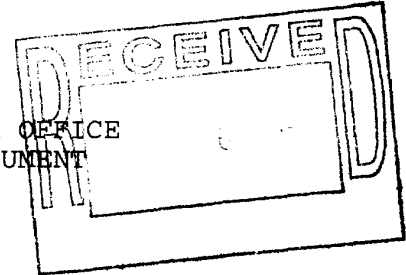


