
NOW, THEREFORE, for good and valuable consideration receipt of which is hereby acknowledged, Assignor agrees as follows:

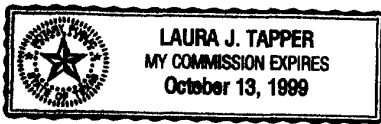
