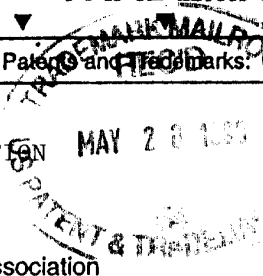

1. The name of the corporation shall be Futorian Furnishings, Inc.


