QUITCLAIM TRADEMARK ASSIGNMENT

This Quitclaim Trademark Assignment (the "Assignment") is made effective as of the 3rd day of March, 1997, by and between Hoechst-Celanese Corporation, a Delaware corporation, having its principal place of business in Somerville, New Jersey (the "Assignor"), and Marcus International, Inc., a Texas corporation having its principal place of business at 616 F.M. 1960 West, Suite 210, Houston, Texas 77090 (the "Assignee")

1. Assignment.

1.1 For good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor hereby assigns and transfers to Assignee, and its successors and assigns, whatever right, title or interest, if any, it may have, in and to the following property (collectively the "Assigned Property"): (i) the trademark and trademark registration described in Schedule A attached hereto (the "Transferred Trademark"), (ii) the goodwill of the business symbolized by the Transferred Trademark, and (iii) any cause of action that has heretofore arisen or that may arise hereafter with respect to unconsented use or infringement of the Transferred Trademark.

2. No Representation.

2.1 By accepting this Assignment, Assignee acknowledges that the foregoing assignment is being made on an AS IS, WHERE IS basis, that the Assignor has not made any representations or warranties to Assignee of any type whatsoever with respect to the Assigned Property or the nature or extent, if any, of its rights therein, and that Assignee has conducted whatever investigation Assignee deems appropriate with respect to the existence, condition, validity of or other matters affecting the Assigned Property.

3. Further Assurances.

3.1 The Assignor shall execute, or use its best efforts to have executed, at the expense of Assignee, such further instruments or documents as may be reasonably requested by Assignee in order to more fully effectuate the assignment of the Assigned Property pursuant hereto.

4. Assigns

4.1 The benefits and burdens of this Assignment shall inure to the benefit of and be binding upon the respective successors and assigns of the parties.

5. Governing Law.

5.1 This Agreement shall be governed by the internal laws of the state of Texas.

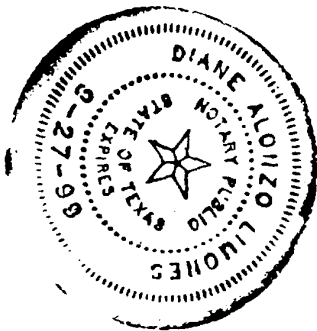
