## ASSIGNMENT AGREEMENT

THIS ASSIGNMENT AGREEMENT ("Assignment Agreement") is made effective as of this 12th day of December, 1995, by and between Lord Corporation, a Pennsylvania corporation, having a place of business at 2000 West Grandview Boulevard, Erie, Pennsylvania ("Lord"), and Lord Techmark, Inc., a Delaware corporation, with its only place of business at 501 Silverside Road, Suite 67, Wilmington, Delaware ("Techmark").

## BACKGROUND

The background to this agreement is as follows. Lord is the owner of 100% of the issued and outstanding shares of common stock of Techmark. Lord is also the owner of certain trademarks, trade names and service marks, together with all registrations therefor and all pending applications for registration therefor, all as more particularly identified on Schedule A hereto (the "Trademarks"). Lord is desirous of assigning all of its right, title and interest in and to each of the Trademarks to Techmark, and Techmark is desirous of accepting the same.

## AGREEMENT

In consideration of the mutual promises and covenants made herein and for other good and valuable consideration, the receipt and adequacy of which is hereby acknowledged, the parties hereto, intending to be legally bound, agree as follows:

(A) Lord does hereby assign, transfer and convey unto Techmark all right, title and interest in and to the Trademarks identified on Schedule A hereto, together with all goodwill associated therewith, including all registrations therefor and all pending applications for registrations therefor.

(B) Techmark hereby accepts the assignment described in Paragraph (A) hereto. Techmark hereby assumes all liabilities and obligations in connection with such assignment, except as otherwise agreed by the parties in writing.


(C) Lord agrees to take whatever further action is deemed necessary or appropriate by Techmark to effect the transfer of the Trademarks properly and completely to Techmark and to establish full custody of the Trademarks in Techmark.

(D) This Assignment Agreement shall be governed by the internal laws of the State of Delaware, without reference to its conflicts of law principles.






