




RELEASE OF SECURITY INTEREST

WHEREAS, DELTA MILLS, INC. granted NATIONSBANK, N.A., as Agent for certain institutional lenders (the "Agent"), a lien on and a security interest in and to the trademarks identified in Exhibit A attached hereto and by this reference made a part hereof (the "Trademarks"), pursuant to a Subsidiaries Security Agreement dated May 20, 1997 (the "Security Agreement");

WHEREAS, notice of the Security Agreement was recorded with the United States Patent and Trademark Office on June 3, 1996 at Trademark Reel 1456, Frame 0396;

WHEREAS, the Agent desires to cancel and terminate all of its liens and security interests on or against the Trademarks;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, and intending to be legally bound hereby, the Agent hereby releases unto DELTA MILLS, INC., effective as of the date hereof, any lien or security interest in and to the Trademarks and any trademark applications appearing on Exhibit A, and any foreign trademarks or applications as set out in the schedules to the Security Agreement, together with the goodwill associated with the foregoing, all books and records relating to the Trademarks or products involving the Trademarks, and any and all proceeds thereof, and any interest ever possessed by the Agent in any claims by DELTA MILLS, INC. against third parties for infringement of the Trademarks and the proceeds therefrom and licensing royalties.
