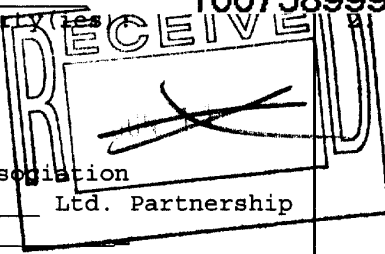


ASSIGNMENT OF TRADEMARK
