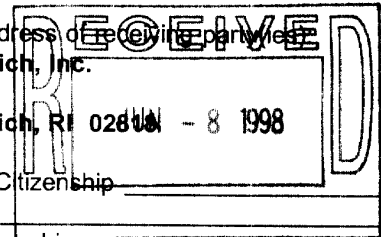




CONFIRMATORY ASSIGNMENT OF TRADEMARKS
