WHEREAS, Assignor is the sole owner of the entire right, title and interest in and to the following trademark, (the "Trademark"), and the registration therefor (the "Registration"), which has been issued by the United States Patent and Trademark Office:

Assignor covenants and agrees that it will, without charge to Assignee, whenever so reasonably requested by Assignee, execute and deliver such further instruments and perform any other reasonable acts that Assignee may require as may be necessary or convenient for vesting in Assignee the full benefit of all of the rights and premises hereby assigned and/or provide evidence to support any of the foregoing in the event such evidence is deemed necessary by Assignee.


Assignor hereby warrants, covenants and represents that it has not heretofore granted any license, right or privilege in respect of the Trademark or in any other way encumbered the same, and that it has the full right to convey, free of all licenses and encumbrances, the entire interest hereby assigned. All such representations, warranties and covenants of Assignee shall survive the execution and delivery of this Assignment.

The Commissioner of Patents and Trademarks is hereby respectfully requested to record this Assignment in the United States Patent and Trademark Office against the file of the Registration herein described.
