



Indústrias Gessy Lever Ltda. its shares in that company, so that the latter became the sole quotaholder of the company to be merged. Then, after a detailed examination of the Report on the Appraisal of the Net Worth of Cica S.A., the shareholders of the company and the representatives of Cica S.A. agreed upon the total amount contained therein, namely, R\$ 125.082.802,59 (one hundred and twenty-five million, eighty-two thousand, eight hundred and two reais and fifty-nine centavos) for the net worth of Cica S.A., appraised at market value, the mentioned Appraisal Reports becoming part of these Minutes as Exhibits. In view of approval of the Appraisal Reports, and as all the conditions contained in the Merger and Justification Protocol had already been approved by both companies involved, it was decided that Cica S.A. would be merged into this company for an amount of R\$ 125.082.802,59 (one hundred and twenty-five million, eighty-two thousand, eight hundred and two reais and fifty-nine centavos) corresponding to the Net Worth of Cica S.A., without any capital increase. In view of the merger now approved and in compliance with the provisions contained in the Merger and Justification Protocol, Cica S.A. was declared to be extinct and the shares of its share capital consequently cancelled, with INDÚSTRIAS GESSY LEVER LTDA. succeeding it in all its rights and obligations, without any interruption, for all legal purposes and effects, it being certain that the units of Cica S.A. contained in the enclosed list shall henceforth operate as units of the absorbing company. Finally, it was resolved that the management of the merged company was hereby authorized to perform all acts supplementary to or resulting from the merger approved hereunder, with broad and general powers to make all the necessary registrations, transcriptions, annotations or communications, particularly to the Real Estate Registry Offices, according to the list attached hereto. As there was no further business to transact, the meeting was suspended for the time necessary to draw up these minutes which, upon the reopening of the meeting, was read, found to be in order, approved and signed by all those present.
