NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor agrees as follows:



This Assignment shall be governed by, and construed in accordance with, the laws of the United States, in respect to trademark issues and in all other respects, including as to validity, interpretation and effect, with the laws of the State of New York. The headings in this Assignment are for purposes of reference only and shall not limit or otherwise affect the meaning hereof.
