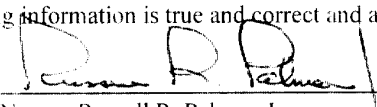

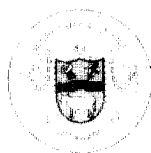

CERTIFICATE OF OWNERSHIP AND MERGER

JINDAS B. SHAH and JAMES A. WATSON certify that:

1. They are the president and the secretary, respectively, of MOBEX FINANCING CORPORATION, a Delaware corporation.
2. MOBEX FINANCING CORPORATION owns all of the outstanding shares of MOBEX CORPORATION, a California corporation.
3. The board of directors of MOBEX FINANCING CORPORATION duly adopted the following resolutions by unanimous written consent as of June 6, 1984:

RESOLVED, that Mobex Financing Corporation merge Mobex Corporation, its wholly-owned subsidiary corporation, into itself and assume all of its obligations pursuant to Section 1110 of the California Corporations Code and to Section 253 of the Delaware General Corporation Law; and

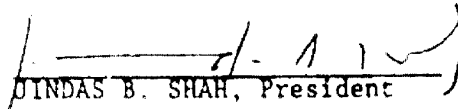
RESOLVED FURTHER, that as of the time that the merger of Mobex Corporation into Mobex Financing Corporation is effective, Article I of the Certificate of Incorporation of Mobex Financing Corporation shall be amended to read:

"The name of this corporation is MOBEX CORPORATION."


4. Pursuant to Section 253(b) of the Delaware General Corporation Law, MOBEX FINANCING CORPORATION hereby amends Article I of its Certificate of Incorporation, as of the effective time of the merger of MOBEX CORPORATION into MOBEX FINANCING CORPORATION, to provide that the name of MOBEX FINANCING CORPORATION shall thereafter be "MOBEX CORPORATION."

We further declare under penalty of perjury under the laws of the State of Delaware that the matters set forth in this Certificate of Ownership and Merger are true and correct of our own knowledge.
