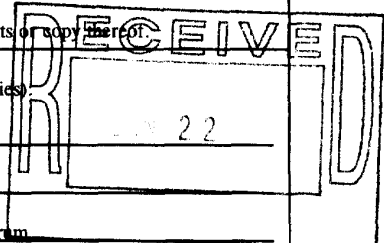

Under Section 905 of the Business Corporation Law

It is hereby certified, on behalf of GTE Corporation, as follows:

1. The names of the constituent corporations are Contel Corporation, a Delaware corporation (the "Subsidiary"), and GTE Corporation, a New York corporation (the "Corporation"). The Certificate of Incorporation of the Subsidiary was filed by the Secretary of State of Delaware on December 16, 1960 under the name Telephone Communications Corporation. An application to do business in the State of New York for the Subsidiary was filed by the Department of State on March 26, 1969 and such application was withdrawn by the Subsidiary on November 5, 1992. The Subsidiary has not used a fictitious name in the State of New York. The Certificate of Incorporation of the Corporation was filed by the Department of State on February 25, 1935 under the name General Telephone Corporation.

2. The outstanding shares of the Subsidiary on December 22, 1995 consisted of 100 shares of common stock, \$0.01 par value, all of which on that date were owned and held by the Corporation.

3. The Plan of Merger has been duly adopted by the Board of Directors of the Corporation, which is the surviving corporation in the merger.

4. The merger (and the completion of the liquidation of the Subsidiary for which a plan was adopted on January 7, 1993) is to become effective upon the filing of this Certificate of Merger by the Department of State.


