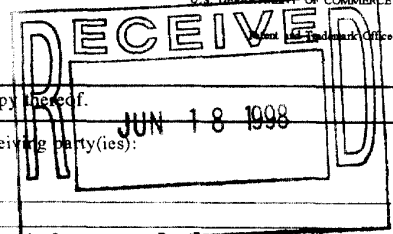

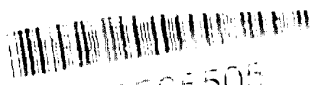

NOTICE OF CORRECTION
TO COVER SHEET RECORDED
AT REEL 1650, FRAME 0946

Applicant filed the above application, ser. no. 75/342,365, which is to be published June 23, 1998. In the course of the examination, applicant advised the examiner that applicant was the owner, under its former corporate name, of three registrations for other NABI formatives, Reg. Nos. 1,478,235; 1,477,531; and 1,767,141.

When the examiner verified this information, she realized that the last transaction concerning the foregoing registrations, recorded at Reel 1650, Frame 0946, was incorrectly coded as an assignment transferring ownership, when in fact, the transaction was a security agreement whereby registrant Nabi had only granted security interests in the trademarks and their registrations. The examiner so advised undersigned applicant's counsel in her Examiner's Amendment mailed April 8, 1998, a true and correct copy of which is attached hereto as Exhibit A.

The erroneous coding was due to an inadvertent error in box 3 of the cover sheet (recorded at Reel 1650, Frame 0946), where the box for an "assignment" was checked instead of the appropriate box for a "security agreement." A true and correct copy of this cover sheet is attached hereto as Exhibit B. The cover sheet was prepared by a representative of the secured party.

This error in the cover sheet and in the coding resulted in an error on the Notice of Publication for this application ser. no. 75/342,365, on which Notice the applicant is erroneously identified as "NationsBank, N.A., As Agent." A true and correct copy of the Notice of Publication is attached hereto as Exhibit C. NationsBank is only a secured party. The owner of the subject mark and the applicant herein remain one and the same person, to wit, Nabi.

In order to keep the record title to this mark and application (i.e., ser. no. 75/342,365) accurate, applicant wishes to record this Notice of Correction to Cover Sheet Recorded at Reel 1650, Frame 0946.

It is anticipated that the "Notice of Recordation of Assignment Document" to be issued pursuant to this Notice of Correction will show the "Assignor" as NationsBank, N.A., As

Agent and the "Assignee" as Nabi, with the following "brief":

Corrects earlier cover sheet
recorded at Reel 1650, Frame
0946, to identify nature of
conveyance as "security
agreement" and not "assignment."

Applicant will file additional papers in order to correct the record title regarding the applications and registrations that are the subject the security agreement recorded at Reel 1650, Frame 0946 (the "1650/0946 Security Agreement").

The subject mark herein and this application ser. no. 75/342,365 were not among the marks and applications/registrations covered by the 1650/0946 Security Agreement. Hence the cover sheet filed herewith refers only to the one application ser. no. 75/342,365. Please note in box 3 "Nature of Conveyance" that applicant has checked "other" and supplied the description, "Correction of cover sheet earlier filed at Reel 1650, Frame 0946."


