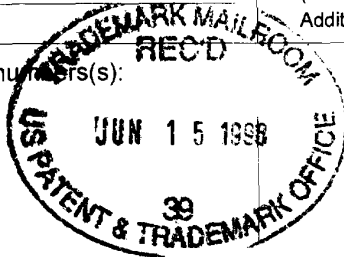


ASSIGNMENT AGREEMENT


