1. The name of the corporation is Windy Hill Pet Food Company, Inc. (hereinafter referred to as the "Corporation").


2. The certificate of incorporation of the Corporation is hereby amended by striking out Article FIRST thereof and by substituting in lieu of said Article the following new Article:
