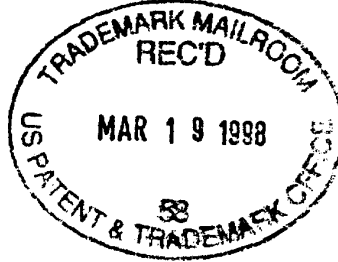

Richard W. Withers, Chairman of the Board of Lany Fax of America, Inc., a Delaware corporation, hereby declares as follows:


Lany Fax of America, Inc. is the owner of certain U.S. Trademark registrations which are registered under the name of Lany Fax of America, Inc., an Illinois corporation, those trademark registrations being:
