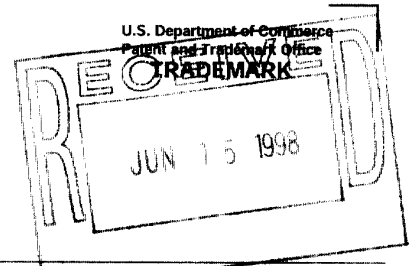

TO THE
ARTICLES OF INCORPORATION
OF
DOW B. HICKAM, INC.

Corporations Section

Pursuant to the provisions of Article 4.04 of the Texas Business Corporation Act, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation:

ARTICLE ONE

The name of the corporation is Dow B. Hickam, Inc..

ARTICLE TWO

The following amendment to the Articles of Incorporation was adopted by the sole shareholder of the corporation on February 8, 1994. The amendment changes Article One of the original or amended Articles of Incorporation of the corporation and the full text of the provision altered is as follows:

*ARTICLE ONE

The name of the corporation is Dow Hickam Pharmaceuticals Inc.*

ARTICLE THREE

The number of shares of the corporation outstanding at the time of such adoption was 1,000; and the number of shares entitled to vote thereon was 1,000.

ARTICLE FOUR

The holder of all of the shares outstanding and entitled to vote on said amendment has signed a consent in writing pursuant to Article 9.10 adopting said amendment and any written notice required by Article 9.10 has been given.
