**FIRST: The name of the corporation is Super Club Music Corporation (the "Corporation").**


**SECOND: Article I of the Certificate of Incorporation of the Corporation is hereby amended as follows:**


**"The name of this corporation shall be Blockbuster SC Music Corporation.**
