2. Its registered office in the State of Delaware is located at Corporation Trust Center, 1209 Orange Street, City of Wilmington, County of New Castle, Delaware 19801 and the name of its registered agent at such address is The Corporation Trust Company.
3. The date of filing of the original Certificate of Incorporation in Delaware was September 13, 1984.
4. The date when restoration, renewal and revival of the charter of this corporation is to commence is the 28th day of February, 1997, same being prior to the date of the expiration of the charter. This renewal and revival of the charter of this corporation is to be perpetual.
