ARTICLES OF AMENDMENT
TO THE
ARTICLES OF INCORPORATION

Pursuant to the provisions of Title 29, Chapter 3 of the Code of Laws of the District of Columbia, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation:

FIRST: The name of the Corporation is Tele Sec Temporary Personnel, Inc.

SECOND; The following amendment of the Articles of Incorporation was adopted by the shareholders of the corporation on September 4, 1985, in the manner prescribed by the Code of Laws of the District of Columbia:

RESOLVED: That Article 1 of the Corporation's Articles of Incorporation is amended to change the name of the Corporation to "TSTP Corp."

THIRD: The number of shares of the corporation outstanding at the time of such adoption was 1,800 and the number of shares entitled to vote thereon was 1,800.




