

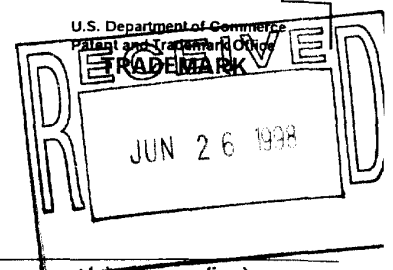

TRADEMARK, TRADE NAME AND ASSUMED NAME ASSIGNMENT

THIS TRADEMARK, TRADE NAME AND ASSUMED NAME ASSIGNMENT (the "Assignment") is made to be effective as of March 1, 1998 ("Effective Date"), by and between Investment Resource Management, L.P., a Delaware limited partnership, with its principal office at 4570 Westgrove Drive, Addison, Texas 75248 ("Assignor"), and ECDC East, L.C., a Utah limited liability company, with its principal office at 127 South 500 East, Salt Lake City, Utah 84102 ("Assignee").

WHEREAS, Assignor and Assignee are parties to that certain Agreement of Purchase and Sale of Assets dated as of April __, 1998, ("Purchase Agreement"), pursuant to which Assignor has agreed to sell and Assignee has agreed to purchase the assets, properties and rights pertaining to the Business (as defined in the Purchase Agreement), including the trademarks and the United States trademark registrations and applications for registration identified and set forth on Schedules A and B, respectively, including variations thereof, and the unregistered trademarks identified and set forth on Schedule C, and any variation thereof, and the foreign trademark registrations and applications for registrations identified and set forth on Schedule D and any variation thereof (collectively, the "Marks"), and various trade names and assumed names, identified and set forth on Schedules E and F, respectively, including variations thereof (collectively, the "Trade/Assumed Names"), and the goodwill of the Business associated therewith;

WHEREAS, Assignee wishes to acquire and Assignor wishes to assign all of Assignors right, title and interest in and to the Marks and the Trade/Assumed Names together with the goodwill of the Business in connection with which the Marks and the Trade/Assumed Names are used;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor does hereby sell, assign, transfer and set over to Assignee its entire right, title and interest in and to the Marks and the Trade/Assumed Names together with the goodwill of the Business in connection with which the Marks and the Trade/Assumed Names are used, and all registrations and applications therefor, in the United States and for all foreign countries, including any renewals and extensions of the registrations that are or may be secured under the laws of the United States and all foreign countries, now or hereafter in effect, for Assignee's own use and enjoyment, and for the use and enjoyment of Assignee's successors, assigns or other legal representatives, as fully and entirely as the same would have been held and enjoyed by the Assignor if this Assignment and sale had not been made; together with all income, royalties or payments due or payable as of the Effective Date or thereafter, including, without limitation, all claims for damages by reason of past, present or future infringement or other unauthorized use of the Marks and the Trade/Assumed Names, with the right to sue for, and collect the same for Assignee's own use and enjoyment and for the use and enjoyment of its successors, assigns or other legal representatives.

Assignor authorizes and requests the Commissioner of Patents and Trademarks to record Assignee as the assignee and owner thereof.




