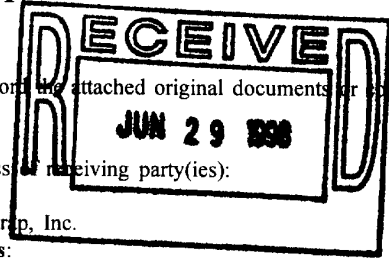

NOW, THEREFORE, for \$1 and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, ASSIGNOR hereby assigns and sells to ASSIGNEE all rights, title, and interest as ASSIGNOR may possess in and to the Trademark and the Application and all rights and business pertaining thereto, including the right to sue and recover for past infringement, together with the goodwill symbolized by said Trademark and Application which pertain to the business of the ASSIGNOR and to which the ASSIGNEE is the successor in interest.


