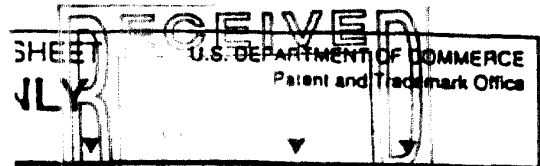

ASSIGNMENT OF TRADEMARK



This Assignment is binding upon the parties, their respective successors and assigns, and all others acting by, through, with or under their direction, and all those in privity therewith.


