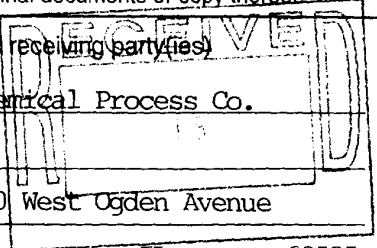


**U.S. TRADEMARK ASSIGNMENT**


