TRADEMARK ASSIGNMENT

WHEREAS, DIAMOND BRANDS INCORPORATED (the "Assignor"), a corporation organized and existing under the laws of the State of Minnesota and having a principal place of business at 1800 Cloquet Avenue, Cloquet, Minnesota 55720, has adopted and used and is the sole and exclusive owner of the trademarks, applications and registrations listed in the attached Schedule A (the "Trademarks"), and of all of the goodwill of the business appurtenant thereto; and

WHEREAS, DIAMOND BRANDS OPERATING CORP., (the "Assignee"), a corporation organized and existing under the laws of the State of Delaware and having a principal place of business at 1800 Cloquet Avenue, Cloquet, Minnesota 55720, is acquiring the Trademarks, together with all of the goodwill of the business connected to the Trademarks, from Assignor in connection with the transactions contemplated under the Recapitalization Agreement made as of March 3, 1998, among SEAVER KENT – TPG PARTNERS, L.P. and SEAVER KENT I PARALLEL, L.P., DIAMOND BRANDS INCORPORATED ("DBI"), and each of the owners of equity interests or options to purchase equity interests in DBI,

NOW, THEREFORE, TO ALL WHOM IT MAY CONCERN, be it known that for and in consideration of the sum of One Dollar (\$1.00), and other valuable and legally sufficient consideration, the receipt and legal sufficiency of which is hereby acknowledged, the Assignor has sold, assigned and transferred, and by these presents does sell, assign and transfer unto the Assignee, the entire right, title and interest in and to the Trademarks, and in and to all of the goodwill of the business appurtenant thereto, together with all claims for damages by reason of infringement of same, with the right to sue for and collect the same for its own use and enjoyment, and for the use and enjoyment of its successors, assigns or other legal representatives.

AND, the Assignor hereby warrants and covenants that it has full right to convey the entire interest herein assigned, and that it has not executed, and will not execute, any agreements inconsistent herewith.

AND, Assignor agrees to execute any instruments and to perform any acts which may be necessary to fully effectuate and record this Assignment at Assignee's cost.

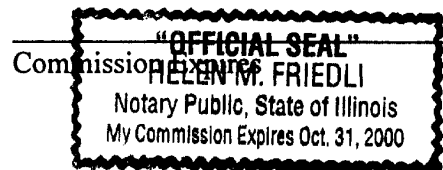
