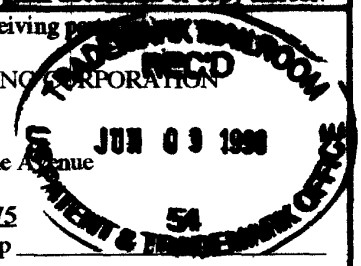



Whereas Randolph K. Geissler was an officer of Destron/IDI, Inc.;

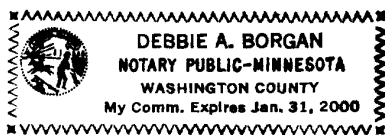


