FIRST: That pursuant to Section 141(f) of the Delaware General  
Corporation Law, the Board of Directors of AGP/GENTech Inc. duly  
adopted a resolution setting forth a proposed amendment of the  
Certificate of Incorporation of said corporation, declaring said  
amendment to be advisable and called a meeting of the  
stockholders of said corporation for consideration thereof. The  
resolution setting forth the proposed amendment is as follows:

RESOLVED, that it is hereby deemed advisable in the  
judgment of the Board of Directors that the Certificate of  
Incorporation of the Corporation be amended by changing
