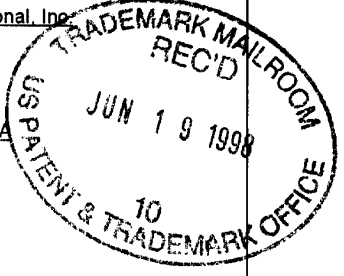



## **TRADEMARK ASSIGNMENT**

WHEREAS, BDH TWO, INC. ("BDH TWO"), a Delaware corporation having its principal place of business at 2711 Centreville Road, Suite 202, One Little Falls Centre, Wilmington, Delaware 19808, is the sole and exclusive owner of the trademarks set forth in the attached Exhibit; and

WHEREAS, Decorative Surfaces International, Inc. ("DSI"), a Delaware corporation having a place of business at 3 Bethesda Metro Center, Suite 860, Bethesda, Maryland 20814, is desirous of acquiring the entire right, title and interest in, to and under the aforesaid trademarks;

WHEREAS, BDH TWO is the owner of all right, title and interest in, to and under said trademarks listed in Exhibit A;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, and intending to be legally bound, BDH TWO hereby sells, assigns, transfers and set over to DSI the entire right, title and interest in, to and under the trademarks set forth in Exhibit A and the goodwill of the business connected with the use of and symbolized by such trademarks, including the right to recover damages and/or profits that have arisen from infringement of such trademarks, with the same to be held and enjoyed by DSI for its use and enjoyment, and for the use and enjoyment of its successors, assigns and legal representatives, as fully and entirely as the same would have been held and enjoyed by BDH TWO if this assignment had not been made;

And BDH TWO hereby authorizes and requests the Commissioner of Patents and Trademarks or other authority responsible for effectuating and/or recording assignments in the country involved, to indicate in its records that DSI is the assignee of the entire right, title and interest in, to and under the trademarks set forth in the attached Exhibit A;

And BDH TWO agrees to execute whatever documents are deemed necessary or desirable by DSI, its successors, assigns or legal representatives to record transfer of ownership of said trademarks from BDH TWO to DSI, all at the expense of DSI or its successors, assigns or legal representatives;

And BDH TWO further agrees that it will, at any time, upon request by DSI, its successors, assigns or legal representatives, deliver any and all papers that may be necessary or desirable to perfect title to said trademarks or to enable DSI or its successors, assigns or legal representatives to obtain and enforce protection for said trademarks, all at the expense of DSI or its successors, assigns or other legal representatives.

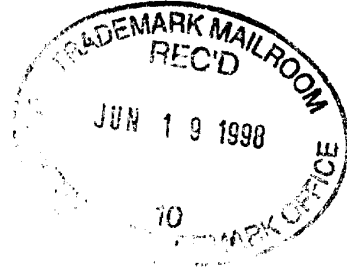
