**ASSIGNMENT AGREEMENT**

Sunshine Electronic Display Corporation ("Sunshine"), a Missouri corporation with a place of business at 501 Sylvania, St. Joseph, Missouri 64501, has adopted and used the mark SKYLINK, and filed with the United States Patent and Trademark Office two applications for federal registration of the mark SKYLINK, namely, Serial Number 74/687,981 (hereinafter "the pending application") and Serial Number 74/687,980, now Registration Number 2,067,735 (hereinafter "the registration"), each filed on June 14, 1995, all in connection with remotely controllable information displays and electronic control circuits and devices for remote control of displays via radio frequency signaling in International Class 9 (collectively the "Mark").

SkyTel Corp. ("SkyTel"), a Delaware corporation with a place of business at 1350 I St., N.W., Washington, D.C. 20005, desires to acquire all of Sunshine's rights, title, and interest to the Mark, together with the goodwill of the business in connection with which such mark is used and the pending federal trademark application and registration for the Mark.

In consideration of the foregoing, and for other good and valuable consideration, receipt of which is hereby acknowledged, Sunshine hereby assigns to SkyTel all its right, title and interest in and to the Mark, together with the goodwill of the business in connection with which the Mark is used, the pending application and registration for the Mark, and the right to claim
