and the number of shares voted against such amendment was zero.

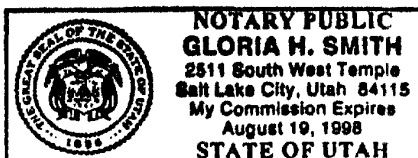
