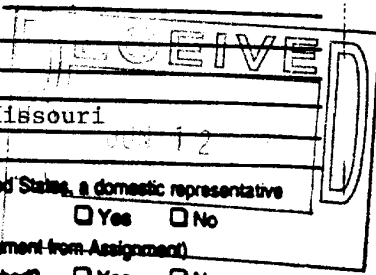



In furtherance of the FIRST AGREEMENT and SECOND AGREEMENT and for good and valuable consideration, the receipt and legal sufficiency of which is hereby expressly acknowledged, ASSIGNOR hereby acknowledges the sale, assignment, conveyance and transfer unto ASSIGNEE, Advanced Wrapping Corporation, its successors and assigns throughout the world, all of ASSIGNOR'S right, title and interest in and to the trademark "Texwrap", U.S. Registration No. 1,694,021 registered in the United States Patent and Trademark Office on June 16, 1992 (the "Trademark"), together with the goodwill of the business in connection with which the Trademark is used and which is symbolized by the Trademark along with the right to sue and recover damages and profits for past infringements thereof. ASSIGNOR further acknowledges that the effective date for this assignment shall be February 5, 1996.
