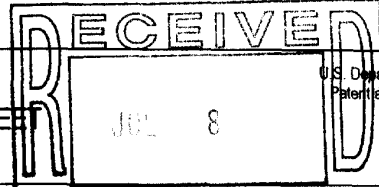

TRADEMARK ASSIGNMENT

TRADEMARK ASSIGNMENT, made as of June 15, 1998 between SRO ARTISTS, INC., a Wisconsin corporation, with offices at Madison, Wisconsin ("Assignor"), and BMG MUSIC, a New York partnership, with offices at 1540 Broadway, New York, New York 10036 ("Assignee").

WHEREAS, Assignee, has used the mark THE WINTER SOLSTICE CONCERTS and variants thereof in connection with concerts, concert tours and booking or promoting concerts or concert tours (collectively, the "Marks") and is the owner of U.S. Registration No. 1,699,357; and

WHEREAS, Assignor desires to acquire the Marks and the Registration and the goodwill symbolized thereby;

NOW, THEREFORE, for and in consideration of the sum of One Dollar (\$1.00) and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Assignor hereby sells, assigns and transfers to Assignee, its successors and assigns, absolutely and forever, its entire right, title and interest, whether statutory or at common law, in and to the Marks and Registration together with the goodwill of the business symbolized by them, including but not limited to all causes of action for any and all previously occurring infringements of the rights being assigned and the right to receive and retain the proceeds relating to those infringements.
